Additional Supplementary Regulations

- 1. Launceston and North Cornwall Motor Club Ltd. will promote a National B/Clubman permit Sporting Car Trial for the David Ayers Trophy at Trevilla Farm, Marshgate, Camelford, Cornwall, PL32 9YN on Sunday 20th September 2015. Map Ref. 190 145911.
- 2. The Meeting will be governed by the General Competitions Rules, Standing Supplementary Regulations of the MSA. Incorporating the provisions of the international Sporting code of the FIA, these SRs and any written instructions of which the promoting Club may issue for the event.
- 3. An MSA permit applied for.
- 4. The event is open to all full elected members of the organizing Club and Northern Phoenix Trials Car Club and any contenders in the BTRDA and Reis ASWMC Sporting Trial Championships and all members of Clubs that are running rounds in the BTRDA Sporting Trials Championship.
- 5. CHAMPIONSHIP contenders MUST provide a valid Competition Licence and Championship Reg. Card. Non-contenders need only a Club Membership Card.
- 6. Passengers of championship contenders must produce a valid card club membership card for L&NCMC or BTRDA special rates available.
- 7. THE EVENT is a round in the BTRDA, MSA and ASWMC Sporting Car Championships.
- 8. SCRUTINEERING will start at 9.00 am. First test will start at 10.30 am. Any Competitor not signed on by 10.00 am may be excluded.
- 9. THE START will be at Trevilla Farm. Public roads will not be used to link sections and there will be 8 sections there will be 3 rounds (weather permitting). The entry will be split into groups starting at different sections.
- 10. All CARS must comply with the BTRDA / MSA tyre regulations. Permitted tyres are Vredestein T-Trac & Sprint +, Toyo 330, Firestone F560, Michelin XZX and Nankang Cx 668.
- 11. THE EVENT WILL CONSIST OF 4 CLASSES:
 - (1) RED CATEGORY AS PER BTRDA LISTING
 - (2) BLUE CATEGORY AS PER BTRDA LISTING
 - (3) GREEN CATEGORY AS PER BTRDA LISTING
 - (4) Non-Championship Contenders in Cars complying with NTCF or 750 Trials Formula (Clubman).
- 12. ALL VEHICLES MUST COMPLY WITH MSA Technical Regulations.
- 13. THE AWARDS WILL BE PRESENTED AS FOLLOWS:DAVID AYERS TROPHY and REPLICA Best Overall Performance
 THE FRANK AYERS TROPHY and Replica Best Performance in Class 4
 CLASS AWARD for best performance in each class
 OTHER AWARDS will be presented at organizers' discretion.
- 14. THE ENTRY LIST opens on receipt of Regs. and closes finally on Wednesday 16th September 2015. THE ENTRY FEE is £30.00. All entries must be made on an official entry form and accompanied by the appropriate fee.
