- 1. The Launceston and North Cornwall Motor Club Ltd will organise a Clubman Sporting Trial on Sunday 10<sup>th</sup> April 2016 at Trecarne Farm, Delabole, Camelford, Cornwall, PL33 9DG (map ref. 200/058 854) by kind permission of Roland Uglow and family.
- 2. The meeting will be governed by the General Regulations of the Motor Sports Association Ltd. (incorporating the provisions of the International Sporting Code of the FIA). These Supplementary Regulations and any written instructions that the organising Club may issue for the event.
- 3. Permit numbers TBA.
- 4. The event is a qualifying round of the 2016 REIS ASWMC Sporting Trials Championship. Registration 51/2016.
- 5. The event is open to any registered ASWMC Sporting Trial contender and all contenders must produce a valid MSA Competition Licence. Passengers of contenders must be members of the organising Club (special lifetime passenger rates available). Non-contenders must be members of the organising Club (Club Membership £10.00).
- 6. The programme will be:- Scrutineering starts are 10:00 am,
  Any competitor not signed on by 10:45 am may be excluded,
  First car starts at 11:00 am.
- 7. Public roads will not be used to link sections. There will be at least 16 sections on private land (weather permitting). The entry may be split into groups starting on different hills.
- 8. The event will consist of five classes as follows:-
  - 1 Red Category BTRDA Contenders
  - 2 Blue Category BTRDA Contenders
  - 3 Green Category BTRDA Contenders and other drivers.
- 9. All vehicles must comply with MSA Technical Regulations. **Please Note** the only tyres allowed are: Nankang CX668, Vredestein T-Trac 2 and Maxxis MA-5ION which are the three tyres permitted by MSA and BTRDA Championship. All vehicles must have effective silencing; any vehicle considered by the scrutineer to be too noisy will not be allowed to start.
- 10. Awards will be presented as follows:
  - 1. The Northgate Trophy to the Best Performance overall.
  - 2. Class win to winner of the other classes.

Other awards may be presented at organiser's discretion.

- 11. The entry opens on publication of regs and closes finally on  $7^{th}$  April 2016. The entry fee is £25.00. All entries must be made on the official entry form and accompanied by the appropriate fee.
