Supplementary Regulations

- 1. The Launceston and North Cornwall Motor Club Ltd will organise a Clubman Sporting Trial on Sunday 29th April 2018 at Ashley Farm, Lifton (MR201/395842) by kind permission of Paul Webber (this is an exciting new site).
- 2. The meeting will be governed by the General Regulations of the Motor Sports Association Ltd. (incorporating the provisions of the International Sporting Code of the FIA). These Supplementary Regulations and any written instructions that the organising Club may issue for the event.
- 3. Permit numbers TBA.
- 4. The event is a qualifying round of the 2018 ASWMC Sporting Trials Championship. Registration 88/2018.
- 5. The event is open to any registered ASWMC Sporting Trial contender and all contenders must produce a valid MSA Competition Licence. Non-contenders must be members of the organising Club (Club Membership £10.00) or members of Camel Vale Motor Club.
- 6. The programme will be:- Scrutineering starts are 10:00 am,
 Any competitor not signed on by 10:45 am may be excluded,
 First car starts at 11:00 am.
- 7. Public roads will not be used to link sections. There will be at least 8 sections on private land (weather permitting). The entry may be split into groups starting on different hills.
- 8. The event will consist of five classes as follows:-
 - 1 Red Driver Independent Suspension as per BTRDA listings.
 - 2 Red Driver Live Axle as per the BTRDA listings.
 - 3 Blue Driver Independent Suspension as per the BTRDA listings.
 - 4 Blue Driver Live Axle as per the BTRDA listings
 - 5 Green Class Novice drivers as per the BTRDA listings and other drivers.
- 9. All vehicles must comply with MSA Technical Regulations. **Please Note** the only tyres allowed are: Nankang CX668, Vredestein T-Trac 2 and Maxxis MA-5ION which are the three tyres permitted by MSA and BTRDA Championship. All vehicles must have effective silencing; any vehicle considered by the scrutineer to be too noisy will not be allowed to start.
- 10. Awards will be presented as follows:
 - 1. The Northgate Trophy to the Best Performance overall.
 - 2. Class win to winner of the other classes. (Subject to at least 4 entrants).

Other awards may be presented at organiser's discretion.

- 11. The entry opens on publication of regs and closes finally on 26^{th} April 2018. The entry fee is £28.00. All entries must be made on the official entry form and accompanied by the appropriate fee.
- 12. All entries must be sent to Pam Wevill, The Manor House, Lifton, Devon, PL16 0BJ (telephone 01566 784451).

13. The maximum entry for the meeting is 40. The minimum is 8. The minimum for each class is 4. Should any minimum figure not be reached the organisers have the right to cancel the meeting or amalgamate the classes. Entry fees may be refunded if notified by 26^{th} April 2018.

- 15. Provisional results will be published following the end of the event.
- 16. Any protest must be lodged in accordance with 06.2.6.
- 17. Starting numbers will be decided by ballot and provided by the organisers.
- 18 The finish will be at the venue. No refreshments available on site.
- 19. Results Provisional results on the day and copies within 14 days.
- 20. Directions from A30 west or east take Lifton turning at Lifton Down. Proceed on old A30 to Lifton Village (1 mile), at Lifton Hall Hotel, right into Leat Road (arrowed/marked unsuitable for HGVs). Straight on over river bridge and after old railway bridge bear left, 2nd right (by cottage) up steep narrow hill for a further 400m and right into field before junction.
- 21. Please note, strictly no unauthorised vehicles or motorcycles to be taken beyond the paddock.
