## SPRY TROPHY TRIAL for Sporting Trials Car - 27 January 2019

## **Supplementary Regulations**

1. The Launceston and North Cornwall Motor Club Ltd will organise a Clubman Permit Sporting Trial on 27 January 2019 at Trevilla Farm, Marshgate, Camelford, PL32 9YN, - Map Ref 190/145/911 By kind permission of David Langley.

2. The meeting will be governed by the General Regulations of the M.S.A. (incorporating the provisions of the International Sporting Code of the FISA), these Supplementary Regulations and any written instructions that the organising Club may issue for the event.

3. Permits have been applied for.

- 4. The event is open to all members of the Organising Club (Club Membership £10.00)
- 5. All competitors and drivers must produce a valid Club Membership Card.
- 6. The programme will be:-

Scrutineering starts are 10:00 am Any competitor not signed on by 10:45 am may be excluded. Starts at 11.00.

7. Public roads will not be used to link sections. There will be at least 12 sections on private land. The entry may be split into groups starting on different hills.

8. The event will consist of 2 classes as follows:-

- 1. Sporting Trials Cars.
- 2. Post-Historical Cars

9. All cars must comply with MSA Technical Regulations. All vehicles must have effective silencing; any vehicle considered by the scrutineer to be too noisy will not be allowed to start.

10. All cars must comply with BTRDA tyre regulations. – *Permitted Tyres* Maxxis MA—510 N, Vredestein T Trac 2 and Nankang CX 668. All cars in post-historical class can use tyres in accordance with with T14 8.1 and T14 8.2.

11. Awards will be presented as follows:-

- (i) The Spry Trophy to the Best Car Performance overall.
  - (ii) An Award for class 2 (subject to 4 starters)

12. The entry opens on publication of regs. and closes finally and definitely on 24 January 2019. The entry fee is  $\pm 18.00$ . All entries must be made on the official entry form and accompanied by the appropriate fee.

  - (b) MSA regulations M4 2.16 will apply.
  - (c) All competitors marks will be lost for hitting a market or driving outside boundary of Section.
- 19. Results Provisional results on the day and copies within 14 days.

20. Directions:- From A39 6 miles east of Camelford by Otterham Cafe turn north towards Marshgate after 500 yards into gated track. Park in lane before farm.
