SUPPLEMENTARY REGULATIONS TESTING TRIAL on Sunday 22nd August 2021 For Motorcycles (Non-damaging)

Launceston & North Cornwall Motor Club Ltd will organise a Testing Trial open to both motorcycles and outfits. The event will be governed by sporting code of the AMCA, these regulations and any others than may be issued later.

- 1. *The Event* A single venue event on private land at Smithson Farm, Kelly, Lifton, Devon [MR 201/414816] and will consist of a number of observed tests. Marks will be awarded for completion of each test or section correctly as well as times taken where appropriate. There will be a number of tests and rounds dependent on time and size of entry.
 - Scrutineering and signing on will commence at 10.45 am. All competitors must be signed on by 11.15 am and the first competitor starts at 11.30 am with a lunch break to follow after completion of the morning rounds.
- 2. Eligibility The event is open to all members of the Launceston & North Cornwall Motor Club Ltd and by invitation to members of Holsworthy, Camel Vale and Wind Whistle Motor Clubs. who are full paid up members for 2021. Note Membership can be arranged on the day. Competitors must be prepared to show the 2021 membership cards on request. Competition licenses are not required. Riders age 6 to 15 subject to AMCA rules including maximum capacity & parental consent.
- 3. Riders underAMCA Permit No. 38528
- **4. Classes** Normal classic trial classes will not apply. Instead vehicles will fall into the following classes.
 - d. Motorcycles
 - e. Motorcycle Outfits

5. Awards

There will be separate awards for performances in each class subject to 4 starters in class. Motorcycles and outfits will be combined for Motor Cycle trophy

Other Class Awards will be at the organiser's discretion Overall awards will be based on index adjusted times.

6. Entries Open immediately and close finally on Tuesday17th August 2021 Late entries will not be accepted. Entries must be made on the correct form (or photocopy) and should be completed with the entry fee of £15.00[Under 18 ± 6.00] and sent to –
